In 2006, Molex introduced the global "ECOCARE" initiative to demonstrate our dedication to environmental protection and the establishment of environmental, health and safety (EH&S) management systems throughout our organization. This documented policy is intended to address the needed framework of EH&S leadership to fulfill the requirements of international standards.

To minimize the environmental impacts and occupational health and safety risks of business activities, products and services, we shall:

**O**perate our facilities in a way that considers the efficient use of natural resources and provides a safe and healthy workplace. Develop products that minimize environmental impact

Continually improve our environmental, health and safety performance and operations

Advise Molex employees and business partners of the importance of adhering to this Policy

 $\mathbf{R}$  educe or eliminate emissions and discharges through pollution prevention activities. Prevent injury and illness through management practices

**E**ducate employees to work in an environmentally responsible and safe manner with a commitment to their consultation and participation within the EH&S systems

Our goal is to be a responsible business, and we are committed to monitoring our EH&S management systems to make sure they are effective. We have posted this policy on molex.com and our internal intranet site.

#### **6.1 Define Program Responsibilities**

### Management

To meet our commitment, Molex Management shall ensure:

- Responsibilities and authorities for relevant roles are assigned and communicated within the organization and shall retain accountability for ensuring the actions are performed.
- EH&S management systems conform to the requirements of applicable international standards.
- EH&S performance is reported on a periodic basis.
- Operations are implemented and maintained in accordance with applicable compliance obligations.

• Molex supply chain partners shall comply with Molex EH&S requirements.

• As a partner in our sustainability efforts, supply chain partners shall support EH&S initiatives undertaken to achieve the intended outcome of our management system performance. Examples may include emissions reduction, responsible sourcing, substance restriction management, etc.
